The Latin America and Caribbean Learning and Rapid Response Helping Improve Democracy, Human Rights, & Governance Work in LAC



Background

Latin America and the Caribbean (LAC) countries are currently seeing the largest share of declines in democracy-focused Sustainable Development Goals. Throughout the region, this trend has resulted in weakened institutions, increased corruption, and full democratic crises. If not addressed, these factors will impede efforts to promote inclusive growth, reduce poverty, bolster resilience, and strengthen democracy throughout the region.

Activity Overview

The Latin America and Caribbean Learning and Rapid Response (LACLEARN) activity is a task order managed by the Latin America and Caribbean Bureau's Office for Regional Sustainable Development (LAC/RSD) to help address this issue. A four-year activity under the USAID Analytical Services IV IDIQ, LACLEARN contributes to improving USAID's Democracy, Human Rights, and Governance (DRG) work in LAC through two primary work streams:

- Analytical Services: Strengthening sector learning and building evidence through gender-informed analytical research, assessments, studies, and trainings that contribute to the DRG sector.
- 2. **Rapid Response:** Targeted short-term technical and analytical activities until mechanisms can be mobilized.

LACLEARN can accept Mission buy-ins for learning and analytical activities.

Anticipated Activities for FY21:

- Develop a LAC DRG Learning Agenda to define learning questions, prioritize thematic areas, address critical knowledge gaps on key DRG challenges in the LAC region, guide investments and programming.
- Design and pilot a Gender-Based Violence Impunity Assessment Tool to collect multicountry information and regional analysis on genderbased violence (GBV), including country case studies.
- Analyze trends and democratic norms and attitudes in LAC to identify drivers of changing attitudes on specific subgroups, like youth and women.
- Conduct citizen security, democracy, governance, and human rights assessments that are tailored to Mission strategic planning and program development.
- Provide technical support for country-level response preparedness to improve technical capacity and identify potential partners and key piloting opportunities.
- Support a Grants Under Contract Program and Rapid Response Mechanism for research and local partners initiatives to address DRG challenges and support innovative programming.
